

# How to legally obtain a deferment from military service?

Each code starts recruitment for military service and every year more guys are all crook trying to avoid it. But few people know that there are legitimate grounds for deferment from military service.

There are good reasons to legally obtain a deferment from service in the army, namely: for health reasons, for family reasons (recruits have disabled parents, it is the guardian of a minor, he's a single dad, his wife is pregnant he had two or more children, have a child or wife with a disability, the recruit is an orphan), to get an education or to pursue professional activity. Most importantly, their right must be justified by relevant documents.

The package of documents is simple: the statement of the recruit on deferment, certified copies of the documents on disability of persons, a certificate of family composition and the supporting documents specified in the application, disabled persons there is no one to.

Due to lack of knowledge and fear of the recruits of the tenth road bypass recruitment. If there is a legitimate reason to delay &#8211; no problems at all, one has only to come to the military enlistment office and provide the documents confirming this right, and deferment will be granted.

However, recruits are afraid, listen to "word of mouth" do not rush to the military Commissariat with the documents which confirm the right to defer. Often, mistakenly summons comes again, this fear is not necessary, simply to inform us that the delay has been given, or to confirm that the documents.

A temporary reprieve from the passage of military service for health reasons is granted to those who have suffered a serious injury: fracture of the upper and lower limbs, the herbs production, etc.

Medical Commission in the military is of great benefit, because it allows to evaluate the state of health [popular essay writing service](#) of recruits and to identify dangerous disease. "Remember the last time you received a comprehensive medical examination? Tests? Recruits undergo a detailed review by experts. The results of the medical Commission show that many potential soldiers are not fit for military service for health reasons. The inspection and manipulation of many of the recruits of different ages are able to detect initial one is already running stages of tuberculosis, hepatitis b and C, syphilis and even HIV.

Legitimate reason to get a deferral from military service &#8211; training in vocational schools or University on the daily form of education. If the student is studying in absentia, such a right loses.

Also eligible for the deferral granted to those who are learning in internship, postgraduate study and doctoral studies.

The right to defer applies to those students who are studying abroad. The recruit must provide a certificate stating that he is a student of a foreign educational institution. However, the document needs to be translated and the translation notarized.

Teachers eligible for a deferment if they are taught in school in their field with a full load, and it is &#8211; 18 hours per week.

The right to deferment from military service to pursue professional activity, have doctors working in rural areas under condition of full load on their positions.

Police, as well as those who serve in the military reserve, for military service in the army, too, do not call.

Also can not be called convicts. This requires law enforcement agencies to submit the relevant document from the police, prosecutors or the court.
